## Privacy Policy

Cumberland Country Golf Club Limited (the Club) is subject to the provisions of the Privacy Act 1988. The personal information provided by you on this application form and the attached documents will be used to process your membership application. Failure to provide all of the requested information may result in your application being rejected. You have a right to access and correct any of the personal information that the Club holds about you.

The Club does not usually disclose your personal information to any other organisation or person unless there is a legal requirement to do so. The Club may disclose some personal information about you to third parties that provide services under contract to the Club. These contracts require the third party to keep your personal information confidential and secure. An example of a third party who may have access to your personal information is the company that prints the annual golf fixture book.

Your personal information may be used by the Club for marketing purposes to improve our services and to provide you with the latest information about those services and any new related services and promotions.

Notwithstanding anything else in this statement, you may, at any time, advise us that you do not wish to receive any direct marketing communication. You may do this by phoning or visiting our office. The opt out request will apply to all direct marketing material normally sent to you, except the Club's Newsletters that will contain prescribed notices of meetings and other notices of changes that are required by law or the Club's Constitution.

**Members Interview**

You will be required to attend an interview accompanied by your proposer with the Membership Committee at a date to be arranged by the club. Attendance is compulsory. The club will accommodate changes where it is able.

**Entrance Fee**

The Entrance Fee payable on your Membership being approved by the Board of Directors is \$500.00. This is a once only non-refundable payment. By becoming a Full Provisional or 5 Day Member of Cumberland Country Golf Club you agree to pay the full joining fee.

**Annual Subscription**

Annual subscription fees are payable on or before 30 September of each year as the Club's subscription year is from 1 October to 30 September. The amount of the current annual subscription fee may be obtained from the Office.

**Payment of Fees**

The entrance fee and annual subscription are payable following the acceptance of your membership at our monthly Board meeting (normally held the last Tuesday of the month).
