Type of Information Collected

How will we use and Disclose your Personal Information?

Generally, we will use and disclose your personal information for the following purposes:

- To provide a service to you
- To register you for clinics, lessons, rounds and events at Cumberland Golf Club
- For direct marketing of our products and services (we will always provide you with the opportunity to decline any further marketing communications)

We declare that personal information will not be sold to companies for mailing purposes.

Refund Policy:

- It is Club policy that no refunds are available on membership; unless
- Per 16.11 of the Club Constitution
"The Club shall not be required to notify a person if they have been elected to membership. If a person fails to be elected to membership the Secretary shall cause any joining fee and subscription paid by the person to be returned to that person."

Delivery Policy:

- All payments made through this web site are processed through a secured gateway layer.

Security Policy:

When purchasing from Cumberland Golf Club, your financial details are passed through a secure server using the latest 128-bit SSL (secure sockets layer) encryption technology. 128-bit SSL encryption is the current industry standard.
